

- i. Your Affiant later conducted a review of publicly accessible Instagram profiles, during which time he located Instagram profile "westsh2000," which included a photograph of a white male consistent with the South Dakota driver's license image of Steven West (DOB: and which contained the name "Steve West" in the description section.
- c. After arriving at West's residence and each juvenile female shaving their heads, West told that she needed to have sex with him. Additionally, for extra money, and could perform "blow jobs" on West.
- d. Eventually, all three juvenile females went into a bedroom with West, where and performed fellatio upon West. Following such, West and had penile-vaginal sex on the bed. advised West did not use a condom and described West ejaculating inside of her. In return for the sex, West provided the juvenile females \$180.00.
- e. Afterwards, West drove all three juvenile females to Vivian using West's white pick-up truck.
- f. confirmed being connected with West online, as West would solicit for nude images. would send nude images she would locate on Google. West would in turn pay via the application PayPal.
 - i. consented to a review of her cellular device, and in particular her PayPal account. In the transaction history of the application, Your Affiant observed numerous transactions involving a "steve west" spanning the dates April 25, 2021 through May 10, 2021. To include one particular transaction dated May 11, 2021 for the amount of \$30.00 with the memo line "PLEASE. So you can come pick me-up at 8 at the city park tomorrow."
- identified as West, phone number (605) In the selection of text messages Your Affiant reviewed, Your Affiant took note of kiss and heart emojis sent from West's phone number along with a discussion of meeting and sending what was understood to be money.
 - i. Following this interview, Your Affiant contacted Sully County Sheriff Bill Stahl, as Sheriff Stahl is familiar with West. Sheriff Stahl confirmed phone number (605) to belong to West.
- 6. A review of South Dakota driver's licensing records note Steven Harold West (DOB: by to reside at Bayberry Avenue, Onida, Sully County, South Dakota. This address was updated in the database on or about January 29, 2021.
 - a. Based on Sheriff Stahl's familiarity with the Onida-area, Sheriff Stahl confirmed West to reside at Bayberry Avenue, Onida, Sully County, South Dakota.
- 7. On May 13, 2021, Your Affiant conducted an admission-seeking interview with Steven West (DOB: Following West's waiver of his Miranda rights, he

corroborated his role in providing transportation to all three juvenile females. In addition, West confirmed engaging in various sexual acts with all three juvenile females, specifically:

- a. who is 13 years old, performed oral sex on West.
- b. who is 12 years old, performed oral sex on West.
- c. West performed oral sex on who is 13 years old, and then engaged in penile-vaginal sexual intercourse with

Based on the aforementioned information, Your Affiant reasonably believes STEVEN HAROLD WEST to be guilty of the following charges:

- SDCL 22-22-1 (1): Rape in the First Degree
- SDCL 22-22-1 (5): Rape in the Fourth Degree 2 counts

This report is made based upon Your Affiant's best knowledge, information, and belief.
