

Fact sheet (Updated July 29, 2009)

Tacoma's Safe and Clean effort is driven by the first priority in the Tacoma City Council's strategic plan- that Tacoma is a safe, clean and attractive community. To reach these goals, City Manager Eric Anderson asked employees and community members to help to tackle two major challenges:

- 1. Make Tacoma safer by reducing crime within the city by 50 percent
- 2. Make Tacoma cleaner by removing nuisances, debris and junk vehicles

An initial group of 23 teams began their efforts in mid-2008 to work toward these goals. In June of 2009, 17 new teams focused primarily on crime reduction joined the ranks. Below are summaries of the strategies that the new teams are planning to pursue, as well as contact information in case you want to learn more about how you can help a team. Lunchtime Mentoring to Prevent Gang Activity

The team intends to build a program that can be expanded to a citywide effort to connect local role models throughout Tacoma with school children during their lunch break. The team envisions businesses, neighborhood groups, faith-based organizations, community members and local organizations joining together to demonstrate that the community cares about the success of children. The group hopes to tie the mentoring program to an expanded citywide Clean-Sweep event.

Nuisance Codes to Target Crime

The team is focusing on areas where there is both a concentration of nuisance violations and crime. The team will develop a strategy, including training, to engage additional resources in addressing the nuisance issues that are associated with high crime areas within the City of Tacoma. A trial will be performed to measure effectiveness before citywide implementation.

- Current crime data mapped by location,
- Crime trends,
- Crime prevention strategies
- Connections to community groups and organizations working on safety issues.

Graffiti Reduction through Community-Based Art

The team will develop a sustainable method to connect community with professional artists and technical assistance to create beautiful, diverse, and enduring community-based art projects. The effort will primarily focus on properties that are identified as prime graffiti sites by reclaiming them and turning them into places for community art.

Citizens against Prostitution

This team will target street level prostitution by working to reduce street prostitution related crime within Stay Out of Areas of Prostitution (SOAP) zones. Community involvement and the facilitation of the new state impound law will be critical components in the effort. The team is also researching best practices with a goal to create more disincentives for prostitutes and their customers to operate in Tacoma.

Residential Security Training and Outreach; NE Tacoma and Hilltop

Team members are working on a residential security training program. Once trained, team members will offer suggestions for changes to increase security for Tacoma homeowners in targeted neighborhoods. Changes to properties can increase their safety and help reduce the opportunity for burglary.

Resources to address and prevent graffiti

The team is developing a program to proactively deter incidences of graffiti in our community and provide resources to businesses and homeowners victimized by this crime. The team is currently researching what other cities have done to successfully eradicate and/or deter incidences of graffiti and is also learning about existing services and resources.

Target gangs by spotlighting repeat offenders

The team intends to develop strategy that will reduce recidivism of gang members who commit misdemeanors and gross misdemeanor offenses. The team is researching a program that is in place in Spokane, WA to see if it could be applied in Tacoma to address repeat offenders, and is working to invite appropriate stakeholders to join the team.

Improve Alley Security; South 48th – South 56th and Pacific-I-5

This team will perform a pilot project in the area South 48th to 56th from I-5 to Pacific Avenue focusing on safety improvements in alleyways. After program evaluation, the team plans to expand to other areas. At this time, the team has planned to do the following:

- Coordinate with Home Depot
- Perform site security surveys for homes, focusing on Alley's. Provide residents with information via door hangers that will
 include the site survey, fight crime at home pamphlet, Home depot work shop flier, handy phone numbers and resources that
 can help install or repair security issues that need addressed.
- Utilize the program to bring cohesion within the community and their associated support groups, churches, schools and businesses.

Reduce Theft from Motor Vehicles; 6th Avenue & UPS

The team's goal is to reduce theft from motor vehicles around 6th Avenue and UPS through a combination of educational materials, block watches, and improvements to environmental design.

Develop and Distribute Gang Resource Inventory

The intent is to disrupt the cycle of multi-generational gang activity by taking inventory of the existing groups / agencies and tp identify existing resources and services available.

Program will be focused around four main activities:

- Define the multi-generational culture and associated phases of gang involvement.
- Take inventory and evaluate resources already available within the community.
- Determine best channels, facilitate and disseminate information.
- Create a sustainable plan.

Targeting Spaces Prone to Crime in the West Mall Neighborhood

Provide Crime Prevention Through Environmental Design (CPTED) educational materials, security assessments and physical improvements which will result in reduced opportunity for crime in the West Mall area in the short-term and provide guidance for long-term safe development. The project will initially focus on S. 45th to S. 48th Streets between Pine Street and Union Avenue.

Car Prowl Prevention Team

The Team has/will assemble and create educational materials for distribution. Using the educational materials, the Team will create public awareness of how to reduce the opportunity for crime.

The Team is researching materials from other successful programs in other communities to develop a targeted program in Tacoma.

Initially, the Team plans to conduct outreach at the Tacoma Mall, Tacoma Public Library and to City of Tacoma employees. Subsequent activities will focus on those areas where car prowling is reported most frequently, with Team members distributing materials door to door or car to car after initial program development.

Ex-Offender Re-Entry

The team would like to promote effective re-entry plans that provide continuity from incarceration back into the community that uses existing community resources. There are several potential strategies that the team is exploring including:

- Inventorying services and the degree of success experienced through these services.
- Evaluating drug court model for application to misdemeanor offenses.
- Identifying tools for successful re-entry.
- Researching opportunities to incent treatment.

How can I get involved now?

What are the expectations and limitations for the Safe and Clean efforts?

There are no additional budget resources devoted to the Safe and Clean effort at this time, so all of the efforts must be tackled within the current City of Tacoma budget. There is also an expectation that the efforts will all include an element of public outreach and partnership, as we work with the community to Make Tacoma Safe and Clean.

What crimes will be measured?

Information about quality of life crimes that is collected by the FBI under the National Incident Based Reporting System will be those measured in the Safe and Clean effort. These crimes include Assault, Burglary, Destruction/Damage/Vandalism of Property, Homicide, Larceny/Theft, Motor Vehicle Theft, Prostitution, Robbery, Sex Offenses (forcible), Sex Offenses (non-forcible), Stolen Property, and Weapon Law Violations.

Another community resource for you is Safe Streets. Safe Streets assists neighborhoods in organizing block groups. There are also things that you can do in your every day life to help make Tacoma safer and cleaner.

- 1. Talk to your neighbors- Getting to know your neighbors and talking about what you're seeing is one of the most effective steps in reducing crime and blight. Learn their names and the names of their kids. Go for walks around your neighborhood together. Most importantly, share your contact information.
- 2. Report crime and blight- When you see a problem in your neighborhood, report it! If you see a crime in progress call 911. If it's not an emergency, such as graffiti, call the police non-emergency number at 798-4721. To report blight or a violation of the Tacoma City code, call Tacoma Cares at 591-5001.
- 3. Make your own home safe and clean- There are a lot of things you can do to your own home to help prevent crime. Modifying your own home by using CPTED (Crime Prevention through Environmental Design) techniques is an effective way of reducing the risk of crime happening to you. To learn more about CEPTED, call Tacoma cares at 591-5001.
- 4. Learn more about City services that are available and spread the word- Did you know that each Tacoma City household gets two Call-2-Haul pick ups a year to dispose of items that are too large to fit in the garbage container. That's just one of many services that the City provides.
