
PROFESSIONAL TRAINING 0 → x

2020 ROADMAP

JANUARY- Unbound educated over 700 Texas A&M students & faculty members over how pornography impacts human trafficking

DECEMBER- Provided Christmas presents for our 7 locally placed survivors

THE NUMBERS COME TO LIFE

We 1st met Aurora* through a partner agency after she moved into our area. Aurora was homeless & in need of immediate services. Our Advocate provided Aurora with a survivor bag & connected her with the Unlimited Potential Program where they obtained immediate housing. Aurora & her Advocate, continue to work on processing through her trauma, peer support, basic needs & obtaining employment. Aurora has continued to make progress with the help & support of her advocate.

After responding on scene to a local motel, Unbound advocates were able to build relationships with 1 minor & 1 adult sex trafficking victim. The survivors were given Unbound survivor bags & a hot meal to make sure their basic needs were met. Our advocates assisted for 10 hours on scene, at the hospital & the local child advocacy center. Following their recovery, advocates are committed to connecting these survivors with continued services & support.
