JOUBERT contacted the number listed on the advertisement and began a several hours long conversation where he and the officer negotiated and agreed upon sexual acts in exchange for \$80, according to JOUBERT. Additionally, he was asked to bring soda. JOUBERT agreed to meet the subject of the advertisement in room 102 at the Hampton Inn. Upon arrival, JOUBERT knocked on the door to room 102 and was taken into custody by officers in the room.

R/O and D/Lt. Lopez of the Genessee County Sheriff's Department spoke with JOUBERT at the Berrien County Sheriff's Office in Niles. JOUBERT was read his Miranda Rights and agreed to speak to officers. JOUBERT told officers he went to the Hampton Inn to meet the subject of the advertisement where he planned to exchange \$80 for "sexual favors." He advised he was strugging with his decision prior to entering the hotel. He stated when he approached the room, he thought about just dropping off the soda and leaving. JOUBERT stated he found the advertisement on Skipthegames.com and that he uses the site a few times per month. He said he typically just uses the website to flirt, and he has never actually showed up to a meeting. JOUBERT stated he accessed the website using his cellphone on 5/12/22, and subsequently used it to communicate with the person he was meeting. JOUBERT advised that he initially thought the person he was meeting was 19, but that she had told him she was underage. He advised underage was 16 or 15 years old. JOUBERT admitted to sending photos to the subject of the advertisement; one of his fingers on either side of his mouth (indicating a common guesture for cunnilingus), and one of his penis.
